Board Resolution For Closing Bank Account - CorporateCases

If your corporate bylaws don't assign someone the power to open a bank account, or if your bank is being super aggravating (sometimes this happens when tellers and bank officers don't understand what corporate bylaws are) and requesting that you show a corporate resolution granting you the power to open a business bank account in the name of your corporation, this is the resolution for you.
