Income Tax in Norway. Income tax is charged on a progressive scale, meaning the more you earn, the more you pay as a percentage of your income. In 2016, most wage-earners will pay 25% tax on the majority of their income. For ordinary employees, income tax is deducted from your salary before you receive it.
